### **Member Spotlight: SCARCE**



SCARCE, a non-profit in DuPage County, helps people discover how easy it is to make a meaningful difference for our environment, our children, and future. Executive Director, Kay McKeen, started SCARCE (School & Community Assistance for Recycling and Composting Education) in 1990, while teaching about recycling and other environmental concerns in DuPage County schools.

Many schools had textbooks sitting in storage, taking up space; while the information was becoming obsolete, costing the schools storage money,

without a plan, other then sending to landfill. Kay started the Book Rescue, which put those books into the hands of those who would use them locally and around the world!

Today, items, from LP records to bikes, books and a whole lot more, are accepted at their reuse center and listed on their website. SCARCE partners with organizations to provide books and supplies to schools, hospitals, orphanages and libraries in more than 105 countries. Their Super Crayon Project involves volunteers separating the crayons that are reusable and recycling the rest by sorting, peeling and then melting them. The liquid mixture is poured into molds to form large crayons beneficial to children with special needs.

Recycling events, hosted by local community organizations, are listed on their website. SCARCE initiatives include:

- Storm Drain Medallions—Volunteers adhere medallions to the curb above a storm drain, warning people not to dump waste of any kind down those drains.
- Bread Tag Recycling—Volunteers collect the plastic tags on loaves of bread or rolls, send them to SCARCE, who forwards them to Danielle Cares for Chairs, who provides a wheelchair for someone who needs one. To learn more, visit their website at **www.scarce.org**.

### **ISTC Exploring Wind Turbine Concerns**

The Illinois Sustainable Technology Center (ISTC), a unit of the Prairie Research Institute at the University of Illinois, has established a Wind Energy Equipment End of Life Working Group bringing together stakeholders from government, recyclers, manufacturing, research, and industry organizations to provide expert insights on barriers and opportunities associated with the recycling and reuse of wind energy equipment in Illinois. This working group also helps define the scale of this material recycling challenge. Finally, the working group considers various material management strategies for wind energy equipment and their potential efficacy within Illinois given existing and anticipated infrastructure, legislation, and economic factors. Ultimately the objective of this effort is to support efforts that minimize the number and volume of windmill blades being disposed in landfills. ### COOK COUNTY's Grand Opening Center for Hard to Recycle Materials

Cook County, a member of IRF, has partnered with South Suburban College to create the Center forHard to Recycle Materials (CHaRM Center). This is a permanent recycling drop-off facility available to Cook County residents that helps divert millions of pounds of waste and other hard-torecycle items from regional landfills and water systems. These include electronics, polystyrene foam, and more.

### Plastic Clamshells - Recyclable or Not?

The common fruit clamshell is clear plastic and that is the focus of this article, not the polystyrene foam variation. For many years, #6 polystyrene was used but since 2000 many suppliers switched to #1 PET and #5 PP as these were accepted in many curbside programs. In 2018, as the world responded to China's ban on imports, North American plastic recyclers told MRFs they couldn't accept these #1 and #5 non-bottle plastics. This caused serious public confusion which still exists today. In 2020, a collaborative project spearheaded by the Foodservice Packaging Institute (FPI) and convened by IRF member RRS examined the difference in recycling rates. A 2021

article in **Resource Recycling** covers the complexity in recycling what appears to be the same material. For now, most Illinois MRFs are asking people to place the clamshells in the garbage but for those allowing them into collections, they must be clean and dry. No food or other materials inside. For most of Illinois, #1, #5, and, of course, #6 clamshells are not currently accepted.

# LEGISLATIVE UPDATE

### Legislative Update from IRA

With only a 3-4 weeks remaining in the Spring session, many of the bills we have been watching appear to lack enough support to pass. However, there are several that have gathered steam and we anticipate passage! Below are bills you may look up on the **state legislative website** for the most up-to-date information communities.



- SB52 Compost Awareness Week, makes recognition a yearly occurrence. Expect Passage
- SB58- Degradable Plastic Single-Use (impacts state agencies, requires a reduction policy) Might make it through.
- SB66 Truth in Recycling bill (Addresses recycling confusion, creates strict label standards)

- SB85 Beverage Container Refunds Act, a variation on the Bottle Deposit backed by can manufacturers. Not expected to Pass.
- SB100 A ban on food service plastic Foam from retailers. Passed House but stranded in Senate.
- SB147 Paint Stewardship EPR bill. Passed Senate Unanimously. Possible House Passage.
- SB1358 Expands composting on farms, with less permit requirements.
- SB2211 Plastic Bag Ban bill.
- SB1398 Lithium Battery recycling bill
- HB1370 Large Event Facilities required to recycle. May fail.
- HB1555 Packaging EPR bill. Changes expected but needs more support.
- HB2569 Compost Procurement bill. Requires the State to use compost in some situations.
- HB3597 EV Truck bill. Intended to support business use of electric trucks.

# **Biden-Harris Administration Announces Availability of \$16 Million for Pollution Prevention in Environmental Justice Communities**

The U.S. Environmental Protection Agency (EPA) announced the availability of \$16 million for two new grant opportunities to support states and Tribes in providing technical assistance to businesses seeking to develop and adopt pollution prevention (P2) practices that advance environmental justice in underserved communities. EPA has published two Request for Applications for P2 investments, which were made possible by President Biden's Bipartisan Infrastructure Law, including the Pollution Prevention Grant: Environmental Justice in Communities, and the Pollution Prevention Grant: Environmental Justice Through Safer and More Sustainable Products programs. <u>More information.</u>



#### USDA Announces Cooperative Agreements for Compost, Food Waste Reduction

The U.S. Department of Agriculture (USDA) has announced the availability of up to \$9.5 million for compost and food waste reduction pilot projects for the fiscal year 2023. The cooperative agreements support projects that develop and test strategies for

planning and implementing municipal compost and food waste reduction plans. They are part of USDA's broader efforts to support urban agriculture. **<u>Read more</u>** 

#### **Stormwater Drain Grant Project**

As part of their sustainability commitments, Dart Container Corporation is taking action to address marine debris, especially plastic litter, in the Great Lakes region. They recently took a major step by contributing \$100,000 in grants to the Council of the Great Lakes' Circular Great Lakes initiative for the purchase and installation of the LittaTrap<sup>™</sup> and other innovative devices to capture debris. Dart is the first manufacturer to sponsor a program of this kind through the Council of the Great Lakes. <u>Visit Dart's website</u> for more information and to apply for a grant.

#### Foam Recycling Coalition Accepting Applications for Grants

The Foam Recycling Coalition has opened the 2023 application period, now through April 25, 2023, for public and private entities seeking to start or improve foam polystyrene recovery in their recycling programs. Eligible entities must engage in operating a material recovery facility, manage residential curbside recycling programs, or manage a drop-off or convenience site recycling program. Previous grant awardees have used FRC funding to purchase equipment, including collection bins and foam densifiers, that aid in the efficient collection and on-site material preparation prior to shipping. No cash match is required. However, additional costs by the grantee may be incurred for related items, such as site preparation, electrical infrastructure, freight, etc. Visit <u>www.RecycleFoam.org/Grants</u> to learn more about foam recycling, read about previous recipients or apply for a grant.
